# **Mission Statement**

The mission of the Riverside Farmers Market is to provide an open air seasonal market for vendors to sell their goods and services to the Black Rock Riverside Community and to create a safe, fun environment for neighbors to shop, eat, and mingle. The Market prides itself on being a community event open for the enjoyment of everyone.

#### **Governing Body**

The Riverside Farmers Market is governed by a Farmers Market Committee and a Market Manager

The Farmers Market Committee will be responsible for:

- Establish rules and regulations, adopting, and amending as needed
- Establish requirements for participation in the market
- · Establish and collect rental fees, schedule free stalls, schedule special events
- Establish the operational schedule for the market
- Promote the Market

• Provide/appoint market manager for the day of the market

- The Market Manager will be responsible for:
  - Orderly and efficient operation of the market on market days
  - Enforcing the market rules and regulations
  - Has the right to determine whether or not an item is fit for sale

### **General Operation**

- 1. The use of the market is restricted to bona fide farmers.
- 2. The market will be open rain or shine.
- 3. The market season's days and hours of operation are:

#### SUNDAYS July 8th – Oct 28th 9:00AM to 12:00PM

\*Note market days and hours of operation must be strictly followed. \*Note each Vendor has a combined hour for set up and break down of stall.

- 4. The Market Manager has the right to regulate a vendor's product mix and if and when there are changes in your product mix you must notify the Market Manager.
- 5. The Riverside Farmers Market will provide space only. Vendors must supply tables and other display equipment. Each vendor is responsible for setting up his/her own display.

6.	The Riverside Farmers Market shall not be responsible for any loss or damage to a vendor's person, property, goods, or money.
7.	All vendors are expected to treat customers with courtesy and without discrimination. Discrimination is not permitted.
8.	Each product should be clearly marked with a sign and price.
9.	Each vendor must identify themselves or their business by use of a sign.
10.	Stall size will be a standard 15ft. by 15ft.
11.	Each farm vendor must have his/her own general and product liability insurance.
12.	Vendors must sign the general release agreement.
13.	The fees will be as follows:

×	Note Vendor wishing to rent for the season will have the option for permanent placement
14.	Vendors must be there for the duration of the market hours.
15.	All refuse accumulated by vendors throughout the day must be removed before the closing of the market.
16.	Vendor must provide proof of City of Buffalo vendor permit, as required by the City Code.

17. All applicable City of Buffalo, County of Erie, and State of New York laws and regulations

must be followed.

16. The Riverside Farmers Market Committee and the Market Manager reserve the right to cancel participation in the market of any vendor who has willfully violated the rules and regulations governing the Riverside Farmers Market. First-time violators will receive a written warning. **Any further violations will result in automatic cancellation**. No refund of fees will be made to a vendor whose use of Market space has been suspended or canceled.
